## FIXING TO THE POLYETHYLENE BLOCK:

STANDARD FIXING IS CARRIED OUT USING 4 FLAT BARS POSITIONED AT THE 4 CORNERS OF THE STOOL, SECURED WITH STAINLESS STEEL SCREWS.
